Code of Conduct: The Local Government Act 2019

As stipulated in Schedule 1 of the Act, the Code of Conduct for Members is as follows:

- 1. Honesty and Integrity: A member must act honestly and with integrity in performing official functions.
- 2. *Care and diligence:* A member must act with reasonable care and diligence in performing official functions.
- 3. *Courtesy:* A member must act with courtesy towards other members, council staff, electors and members of the public.
- 4. *Prohibition on bullying:* A member must not bully another person in the course of performing official functions.
- 5. *Conduct towards Council staff:* A member must not direct, reprimand, or interfere in the management of, council staff.
- 6. Respect for cultural diversity and culture: A member must respect cultural diversity and must not therefore discriminate against others, or the opinions of others, on the ground of their cultural background.
 - A member must act with respect for cultural beliefs and practices in relation to other members, council staff, electors and members of the public.
- 7. *Conflict of interest:* A member must avoid any conflict of interest, whether actual or perceived, when undertaking official functions and responsibilities.
 - If a conflict of interest exists, the member must comply with any statutory obligations of disclosure.
- 8. *Respect for confidences:* A member must respect the confidentiality of information obtained in confidence in the member's official capacity.
 - A member must not make improper use of confidential information obtained in an official capacity to gain a private benefit or to cause harm to another.
- 9. *Gifts:* Members must not solicit, encourage or accept gifts or private benefits from any person who might have an interest in obtaining a benefit from the council.
 - A member must not accept a gift from a person that is given in relation to the person's interest in obtaining a benefit from the council.'
- 10. Accountability: A member must be prepared at all times to account for the member's performance as a member and the member's use of council resources.
- 11. *Interests of municipality, region or shire to be paramount:* A member must act in what the member genuinely believes to be the best interests of the municipality, region or shire.
 - In particular, a member must seek to ensure that the member's decisions and actions are based on an honest, reasonable and properly informed judgment about what best advances the best interests of the municipality, region or shire.
- 12. *Training:* A member must undertake relevant training in good faith.

- 2) In the case of a matter raised in a general debate or by any means other than the printed agenda of the Council meeting, disclosure as soon as possible after the matter is raised.

Under disclosure, the Member must abide by the decision of the Council on whether they shall remain in the Chambers and/or take part in the vote on the issue. The Council may elect to allow the Member to provide further particulars of the interest prior to requesting them to leave the Chambers.

<u>Staff Members</u> of the Council are required to disclose an interest in a matter at any time on which they are required to act or exercise their delegate authority in relation to the matter. Upon disclosure, the staff member is not to act or exercise their delegated authority unless Council expressly directs them to do so.

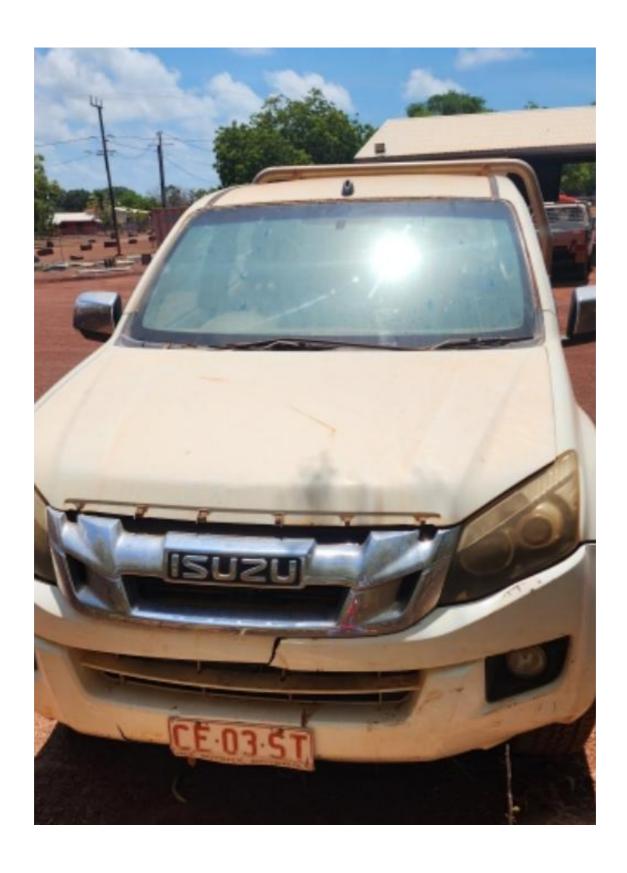

- 2. Ordinary Council meetings will alternate between in-person and online Teams meetings. The in-person meetings will commence on Tuesdays.

- 4. Each Local Authority will meet four times in a financial year.
- 5. Local Authority meetings are not held either side of a public holiday weekend.
- 6. The Risk Management and Audit Committee will meet four times a financial year.
- 7. The Kakadu Ward Advisory Committee will meet four times in a financial year.
- 8. Includes the additional public holiday for the staff and CEO (NAIDOC 10 July 2026).

1. Role

The Minister's Advisory Council for Senior Territorians (MACST) is an independent voice for Territory seniors on issues of interest and importance.

The Council provides high level and strategic advice to the Minister responsible for seniors on issues relevant to the social, economic and civic life of Territory seniors. The Council also provides an effective mechanism, linking the government and seniors community in order to improve policy and service outcomes.

Members participate on a voluntary basis.

2. Authority

The Council is a non-statutory advisory group established by the Minister responsible for seniors. It holds no delegated power to act on behalf of the Minister, or to commit the Minister or government to any actions.

The Terms of Reference align to the Northern Territory Government Handbook for Board Members.

3. Objectives

The objective of the Council is to:

- Provide advice to the Minister responsible for seniors on matters of importance to senior Territorians and in turn, receive feedback from the Minister.
- Explore the needs of the Territory seniors community and offer solutions on how these may be more
 effectively addressed by the Northern Territory Government and service providers.
- Discuss and promote ideas leading to greater awareness of the positive aspects of ageing to the wider community and increase the active participation of older people in all aspects of life in the Northern Territory.
- Receive advice and provide feedback out of session including:
 - Communicating with the Minister and/or the Department of Territory Families, Housing and Communities (the Department) on items under consideration or proposed initiatives across government that may impact seniors;
 - Reporting on wider community concerns that require further consideration of the needs of senior
 Territorians prior to implementation; and
 - Reporting on national and local issues that can be interpreted as being discriminatory on the basis of age.
- Investigate issues that the Minister responsible for seniors may refer to the Council for advice.
- Direct specific tasks to relevant working groups which may be formed to address issues such as economic security, community safety or age-friendly communities.

4. Secretariat

The Office of Senior Territorians will provide secretariat support for the Council. Functions include:

- administrative tasks associated with the appointment of members;
- organising of meetings, including members' travel, where applicable;
- recording and distribution of minutes; and
- disemination of other relevant information.

5. Membership

Membership will comprise of community members, senior peak body representatives, an Aboriginal peak organisation representative, and a representative from local government.

Up to 10 community members will be selected by the Minister for their skills, knowledge, experience, and broader community representation. Community membership will aim to be inclusive of people living in, or with strong connections, to remote and urban communities, culturally and linguistically diverse people, Aboriginal and Torres Strait Islander people, LGBTQIA+ people and people with disability.

Peak body representation will consist of two representative from each of the following:

- The Council on the Ageing (COTA) NT;
- National Seniors Australia:

As well as one peak body representative from each of the following:

- The Association of Independent Retirees;
- A representative from Local Government;
- The Palmerston and Litchfield Seniors Association; and
- A peak Aboriginal organisation.

Other peak body organisations may be invited to participate on the Council by the Minister.

Additionally there will be two (2) observers from the Australian Government, Department of Health and Aged Care.

Upon appointment, members are required to sign and adhere to the Code of Conduct.

5.1. Community member selection and nomination

Community membership is for two years, with the option for re-appointment.

Community members are appointed by the Minister. Processes to fill vacant positions will commence one month prior to expected vacancy dates. Options to fill vacancies include:

- re-appointment of current sitting members for a subsequent term;
- acceptance of nominations through a public expression of interest (EOI) process; or
- direct appointment by the Minister.

5.2. Peak body representation and nomination

Peak body representatives are ongoing appointments and individuals will be selected by their organisation. The organisation will notify the Secretariat of any changes to their representative.

5.3. Chair and Deputy Chair positions

The Chair and Deputy Chair will be be appointed by the Minister from the pool of Community members. The Chair and Deputy Chair will be selected by the Minister for their skills, knowledge, experience and broader community representation.

The terms of appointment for the Chair and Deputy Chair will be a maximum of two (2) years. The Chair and Deputy Chair can be re-appointed by the Minister for a subsequent term following the expiry of their term.

The positions of Chair and Deputy Chair will become vacant in the case of the resignation of a member holding one of these positions or the expiry of their appointment.

6. Meetings

The Council will meet four times a year, with one meeting being held online only. Meetings will be held in two parts:

- Closed session (aproximately 2 hours duration): This session will only be attended by Council members. The agenda will include items related to Working Groups. The Secretariat will be responsible for the preparation of Minutes.
- Open session (approximately 3 hours duration): This session will consist of general agenda items. The Secretariat and relevant Department employees will also be in attendance.

The location of meetings will include a visit to one regional centre per calendar year, noting that arrangements to visit a regional centre will be made within resourcing and budget parameters.

Agenda papers will be circulated to members at least one week prior to the meeting.

A draft copy of the Minutes will be provided to the Chair within 10 days of the meeting. The Secretariat will provide Minutes to the Minister and members once endorsed by the Chair.

A Communiqué summarising the meeting content will be composed following each meeting, and supplied to the Chair with the draft minutes.

Meetings are to be facilitated by the Chair, or in their absence, the Deputy Chair. Where the Deputy Chair is also not present, a member nominated by the Chair will temporarily act as the Chair.

Whenever possible, decisions of the Council are to be made by consensus. If consensus cannot be reached, decisions will be made by a majority vote of those members present. The advice provided to the Minister will include the diverse range of opinions of members.

6.1. Proxies

Peak body representatives can appoint a proxy if unable to attend. All proxies will be coordinated by the peak body member unable to attend.

A community member must seek agreement in advance from the Chair, through the Secretariat, to nominate a proxy.

6.2. Apologies

If a member is unable to attend a meeting, they must submit an apology to the Secretariat. Apologies will be noted in the minutes. If a member fails to attend three consecutive meetings without notifying the Secretariat, their term may be cancelled by the Minister.

6.3. Quorum

A quorum is half the total attending members plus one. A proxy is counted in the quorum and has the authority to vote. Observers or any visiting experts are not included in the count for a quorum and cannot vote.

6.4. Regional participation

Regional participation is encouraged and the Secretariat will arrange flights and accomodation for the travel of members outside of Darwin.

7. Working Groups

All members are to participate in one of the following established working groups:

- Elder Abuse and Community Safety
- Aged Care Workforce
- Concessions
- Housing.

Each working group will have an allocated Chair, who is responsible for the coordination of the group and the Minute taking. A report summarising each group's activities will be presented by the Chair to all members during the closed session of each meeting. The reports will then be provided to the Minister during the open session or out of session. The reports will also be provided to the Secretariat for record keeping.

Each working group will have a Terms of Reference.

8. Confidentiality

Unless otherwise indicated, all papers and minutes are confidential. The Council will determine what papers are marked for release at the end of each meeting, or in subsequent meetings.

Members may be provided with other confidential material, which they should treat with care and discretion and cannot disclose to anyone outside the Council.

9. Declaring conflicts of interest

A conflict of interest may occur where a member has a financial or other interest in issues under consideration by the Council. Declaring conflicts of interest will be a standing agenda item for each meeting.

A member must disclose to the Chair, any situation or agenda item that may lead to a real, perceived, or potential conflict of interest. The Chair will assess the risk and decide if the member be excluded from any discussions.

10. Leave of absence

Members may apply to the Chair, through the Secretariat, for a leave of absence from their Council responsibilities for up to four (4) months. For a period of absence of longer than four (4) months, the request requires consideration by the Minister.

11. Resignation

Members may resign from the Council at any time. All resignations must be provided in writing to the Minister with a copy provided to the Chair. Appointment of replacement members is at the discretion of the Minister.

12. Review of the Terms of Reference

The Terms of Reference will be reviewed biennially in consultation with the Minister, members and Office of Senior Territorians.

SUMMARY

The purpose of this report is to provide the Council with the Financial Management Report for the period ended 30 September 2025 and seek approval for the acquittal of 2024-25 Local Authority Project and Waste and Resource Management funding.

RECOMMENDATION

- 2. Approves all four Local Authority Project Funding 2024-25 Certifications and Project Reports; and
- 3. Approves the Acquittal of Waste and Resource Management grant 2024-25.

BACKGROUND

Monthly Financial Report

The CEO must, in each month, give the Council (or Council's Finance Committee) a report setting out:

- The actual year to date income and expenditure of council;
- The most recently adopted annual budget; and
- Details of any material variances between the most recent actual income and expenditure, and the most recently adopted annual budget.

The report must be in the approved form.

The report must be accompanied by the CEO's certification in writing, to the Council, that to the best of the CEO's knowledge, information and belief:

- The internal controls implemented by Council are appropriate; and
- The Council's financial report best reflects the financial affairs of Council.

If the CEO cannot provide the certification, then written reasons for not providing the certification is to be submitted.

Local Authority Project (LAP) Funding Certification

Annually a certification and project report on all LAP funding for the financial year must be included in the meeting agenda and minutes of the respective Local Authority and included in Council's ordinary council meeting agenda and minutes.

Waste and Resource Management (WaRM) Acquittal

An income and expenditure acquittal for WaRM funding is required to be included annually in Council's meeting agenda and minutes.

COMMENT

The Local Government (General) Regulations 2021 requires the previous month's financial report to be given to the Council.

Local Authority Project (LAP) Funding Certification

Due to the cancellation of the October 2025 Local Authority meetings, out of respect for the passing of a long-term current elected member, only the Maningrida Local Authority considered their 2024-25 LAP Funding certification and project report [MAN63/2025]. The remaining Local Authority 2024-25 25 LAP Funding certifications and project reports will be included in the next Local Authority meeting agendas, which may not occur until the first quarter of 2026. The Department of Housing, Local Government and Community Development has been made aware of this delay and that all 2024-25 LAP Funding certifications and project reports will still be laid before the Council in the October 2025 ordinary council meeting to best, in the circumstances, meet the funding requirements.

Waste and Resource Management (WaRM) Acquittal

Included is the WaRM income and expenditure acquittal for year ending 30 June 2025 which shows a surplus of funds still to be spent.

STATUTORY ENVIRONMENT

Regulation 17 of the *Local Government (General) Regulations 2021* outlines the requirements for the monthly financial report to Council.

The format of the monthly financial report follows the prescribed format set out in the CEO of the Department of Chief Minister and Cabinet's approved form published on the NT Government Local Government Unit's website.

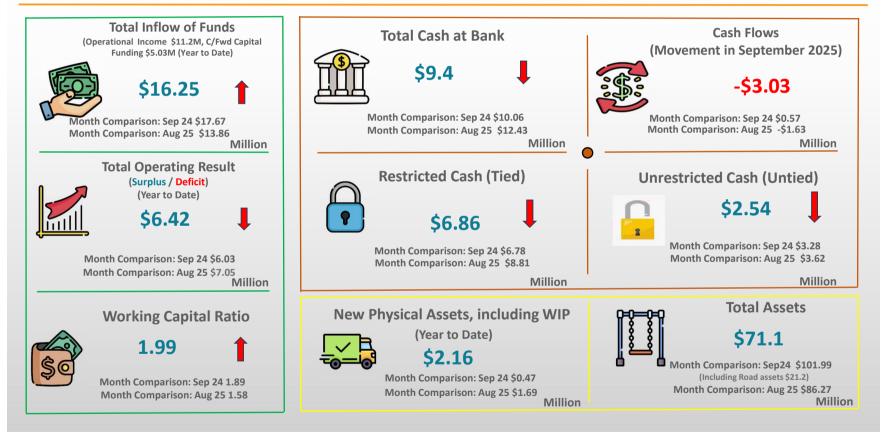

SUMMARY

The purpose of this report is to update the Council on the appointment of the Risk Management and Audit Committee (RMAC) independent Chairperson.

RECOMMENDATION

THAT COUNCIL:

- 1. Receives and notes the report titled Risk Management and Audit Committee Member Update; and
- 2. Approves a revision of the Risk Management and Audit Committee Terms of Reference be laid before the Council, on or before the first ordinary council meeting in 2026, and that the Council continues to seek suitable expressions of interest to fill the vacant independent Chairperson role.

BACKGROUND

On 23 September 2025, the Council approved the advertising for an independent, external member to fill the vacant Chair position of Council's Risk Management and Audit Commitee (RMAC) [OCM230/2025]. The resolution made clear the term of the Chairperson's appointment would be for 3 years and then 4 years thereafter to avoid the term ending at the same time as the term of Council.

COMMENT

The council advertised in the Public Notices of the NT Newspaper on Saturday 4 October and Tuesday 7 October 2025 and on its website the vacant RMAC Chairperson role. One enquiry was made however no applications were received by close of business on Monday 20 October 2025.

The current RMAC Terms of Reference require at least one of the Committee members to be a qualified accountant holding a current professional accounting qualification (i.e. CPA or CA ANZ). Though RMAC still has one independent member (Mr. Warren Jackson whose term will expire 24 May 2027), neither the existing independent member nor the elected members appointed to RMAC are qualified accountants.

It is recommended that:

- The RMAC Terms of Reference be reviewed with options to fill the vacant independent Chairperson role to suit the Council's advisory needs going forward;
- An updated RMAC Terms of Reference be brought to Council to consider as soon as possible being mindful of the time of year; and
- The Council continues to seek suitable expressions of interest to fill the vacant RMAC Chairperson position.

Title: Regional Waste Update

SUMMARY

This report is to provide an update to Council on the status of Waste Management within our communities.

RECOMMENDATION

THAT COUNCIL receives and notes the report titled *Regional Waste Update*.

BACKGROUND

As one of our key operational service delivery areas, Waste Management is an ongoing focus for West Arnhem Regional Council (WARC). Each community has its own unique challenges and opportunities in managing waste in our journey towards circular economy and effective waste management.

COMMENT

1. Regional

- Stop the Drop video has been well received across the region and beyond. There are further resources available to support this program through Sport and Recreation. The video is being played at council offices. Additionally Top End Aboriginal Bush Broadcasting Association (TEABBA) requested the song to go into the song rotation which is fantastic for all involved.
- Replacement bins have been delivered to each community's council office to enable replacing aged and broken bins. It is anticipated that council will replace a quarter of all bins every year to ensure our community members have access to sufficient resources to remove rubbish.
- Unfortunately Keep Australia Beautiful NT failed to receive funding for 2025, so the Tidy Towns program isn't being run this year. It is now integral that council focus its efforts on combating litter in communities by initiating their own litter programs.
- The Waste and Resource Coordinator position was vacant for five months and initiatives such
 as the Reduce Reuse Recycle Strategy will be one of the priorities now that the position has
 been filled. Council can look forward to working towards some tangible waste reductions figures
 into the future.
- Scrap metal recovery commenced 19 August 2025 by Sell & Parker and has now been completed for the 2025 dry season.
- Scrap metal removal by Sell & Parker in Gunbalanya and Jabiru was cut short due to operation requirements in Darwin. Total scrap metal removed in Gunbalanya was 55 tonnes and 13.10 tonnes in Jabiru.

2. Gunbalanya

- Lease Status: Awaiting lease from Northern Land Council (NLC).
- License Status: Requires licensing however this cannot be pursued until lease is issued.

Rubbish Collections:

Banyan: Mondays & Thursdays

Middle Camp: Mondays & Thursdays

Arrkuluk: Tuesdays & FridaysBillabong: Tuesdays & Fridays

- Landfill: Operational from Monday to Friday 7.30am 3.00pm.
- Gunbalanya Landfill is working towards compliance to be ready for licensing when a lease is approved. The focus of this site is to reinstate power to the gatehouse and work towards CCTV to aid in recovery of commercial waste fees. An upgraded loader is also sought for the community as part of the asset replacement program.
- The removal of car bodies and batteries will be carried out in September/October by Sell & Parker free of charge.

3. Jabiru

- Lease Status: Lease with Gundjeihmi Aboriginal Corporation Jabiru Town (GACJT).
- License Status: License EPL351-01.
- Rubbish Collections: Tuesdays and Thursdays.
- Landfill: Operational from Monday to Friday 7.30am 3.00pm.
- The priority for Jabiru is to achieve and maintain compliance with the NT EPA license and work
 with the Office of Supervising Scientist towards best outcome for remediation. A remediation
 progress meeting with stakeholders was held early October 2025.
- The detailed site investigation works have been completed, and a report was received late August 2025. The priority issues are leachate, asbestos and updated the current Environmental Management and Operational Plan.
- A temporary green waste area has been identified to enable interim receival of green waste due
 to confirmed presence of asbestos in town's green waste area. A permanent solution for green
 waste disposal will be discussed at the remediation progress meeting.
- The Waste Resource Coordinator is working with landfill staff, the Finance team, the ICT Coordinator and Information Advisor to develop a waste measurement system to enable accurate and timely recording and reporting of disposal quantities. Once developed and tested it will be rolled out to the other communities.
- Sell & Parker removed one load of scrap metal in October 2025 for a total of 14.16 tonnes.

4. Maningrida

- Lease Status: Awaiting lease from Northern Land Council (NLC).
- License Status: Requires licensing however this cannot be pursued until lease is issued.
- Rubbish Collections: Monday-Friday.
- Landfill: Operational from Monday to Friday 7.30am 3.00pm and although currently unmanned, it is generally well maintained.
- Maningrida Landfill is working towards compliance to be ready for licensing when a lease is approved. The focus of this site is to reinstate power and sewerage to the gatehouse and install

CCTV to aid in recovery of commercial waste fees. Approximately 40 panels of fencing require maintenance or replacement, and works will be undertaken when scrap metal removal works are completed prior to start of the wet season 2025.

- Scrap steel removal commenced by Sell and Parker 20 August 2025 and the last load was recorded 8 October 2025. 1135.8 tonnes was removed and transported to Darwin for further processing.
- Cleansing bags have been delivered to the Maningrida Council office to address exposure issues associated with cultural waste.

5. Minjilang

- Lease Status: Awaiting lease from Northen Land Council (NLC).
- License Status: No license required.
- Rubbish Collections: Mondays and Thursdays.
- Landfill: Unmanned.
- Minjilang Landfill is nearing capacity (estimated 12 months before full), and a key issue is wild
 pigs entering the site and eating waste. This is a public health risk and has the attention of both
 the local authority and NTG environmental health officers. No viable solutions have been found,
 and a lease remains a priority to expand operations outside of the current footprint and create
 a fully fenced compliant site.

6. Warruwi

- Lease Status: Draft lease received from Northern Land Council (NLC) which will be used as a template for other West Arnhem Regional Council landfills.
- License Status: No license required.
- Rubbish Collections: Mondays and Fridays.
- Landfill: Unmanned.
- Challenges for this site include limited space into the future. NTG advocacy needs to be undertaken to ensure that their procurement practices include removal of waste for Warruwi.
- Opportunities for Warruwi are that it is the ideal community to pursue waste sorting and recycling initiatives into the future due to the mature landfill practices and established community garden.

SUMMARY

This report is to provide an update to Council on the progress of establishing declared Cemeteries within our Communities.

RECOMMENDATION

THAT COUNCIL receives and notes the report titled Regional Cemetery Update.

BACKGROUND

The Northern Territory Government introduced the *Burials and Cremations Act 2022* (commenced 28 November 2022) making Local Government the owners of cemetery facilities across the Northern Territory. West Arnhem Regional Council (WARC) has been working towards declaring Cemeteries for all our communities.

COMMENT

Operational staff have worked with our communities across the region to declare and establish community Cemeteries. This program of works involves extensive consultation with community members and landowners to ensure the facilities we are creating are both fit for purpose and culturally sensitive.

Status by Community:

1. Gunbalanya

- Site: Decided.
- Lease: Currently in negotiation with NLC.
- Once the Northern Land Council (NLC) has finalised the lease agreement, this will go back to community consultation for input on design before seeking funding to build Cemetery.

2. Jabiru

- Site: Currently outside WARC lease boundaries.
- Lease: Held by Gundjeihmi Aboriginal Corporation Jabiru Town (GACJT).
- It's not expected that WARC will become the lease holder for this Cemetery. Currently WARC has consent from GACJT to operate the cemetery on Lot 967.
- GACJT represents the Traditional Owners, and they are the final decision makers to allow burials to occur in the Cemetery precinct.

3. Maningrida

- Site: Decided near airport / new sub.
- Lease: Held by WARC.
- Declaration: Issued by the Northern Territory Government.

- Works commenced to expand boundaries 18 August 2025 and Scope 1 works completed 12 September 2025. Sign to be ordered prior to installation of poles at the site.
- Further consultation will be undertaken with the community before determining next work projects.
- Two 6x6 shelters have been ordered for the site.
- Quote for water connections have been requested from three suppliers.

4. Minjilang

- Site: Decided through community consultation.
- Lease: Held by WARC.
- Declaration: Issued by the Northern Territory Government.
- Construction has commenced with Scope 1 work almost complete. Awaiting the delivery of shelter which is delaying completion of Scope 1 works. Trees have yet to be planted, but water is currently available to service them when installed. Vehicle access roads and firebreaks are tidied also.

5. Warruwi

- Site: To be determined.
- Lease: To be determined.
- Ground penetrating radar (GPR) works in Warruwi have been completed with results received by WARC 4 September 2025.
- To determine the best Cemetery site based on GPR results, operational staff will carry out community consultation and apply for a lease over the agreed site.

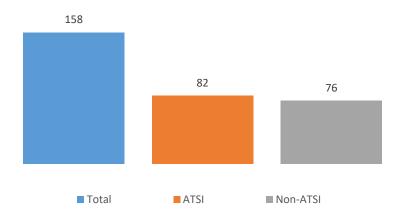

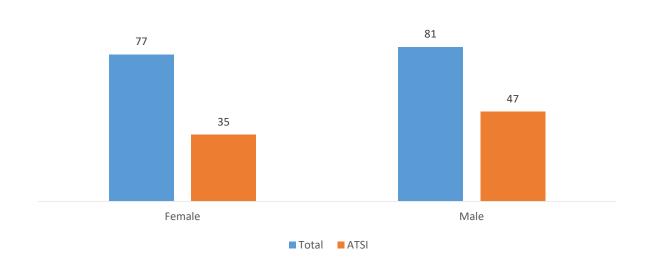

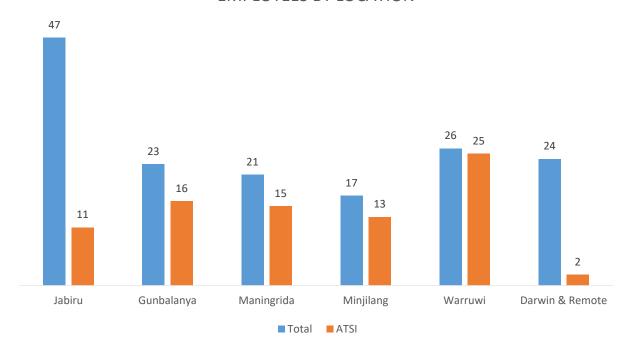
EMPLOYEES BY NUMBER

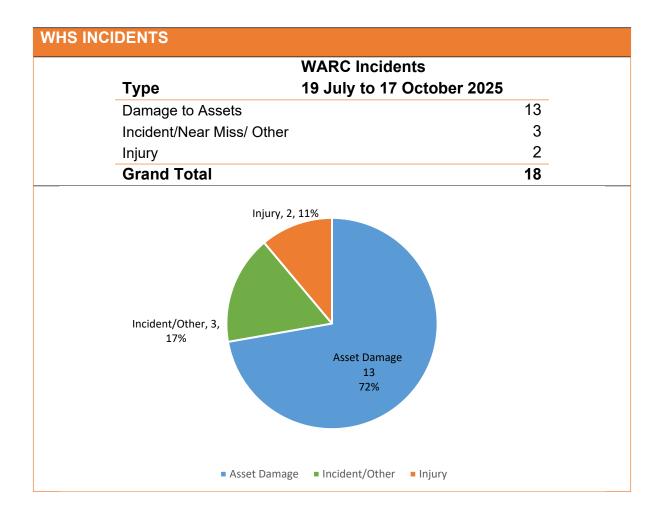

Title: Jabiru Town By-laws 2024

SUMMARY

This report is to provide Council with an updated overview of West Arnhem Regional Council (Jabiru Town) by-law 2024 implementations, specifically Part 5 Animal Management, following repeal of former regulations in January 2025.

RECOMMENDATION

THAT COUNCIL receive and note the report titled Jabiru Town By-laws 2024.

BACKGROUND

West Arnhem Regional Council (Jabiru Town) by-laws 2024 were approved by the Council at a special Council Meeting on December 6, 2024, approved by the Minister on December 17, 2024, and came into effect on January 1, 2025, replacing the previous existing six by-laws for the Jabiru Town.

The new by-laws were designed to ensure the ongoing maintenance and regulation of Jabiru Township. However, Part 5, Animal Management was introduced with a significant gap in current operational and legal processes to support enforcement. These critical deficits include the absence of designated trained regulatory officers not currently in the organisational structure, legal and regulatory process and templates, dedicated administration staff, authorised persons, specialised animal management equipment and modified vehicle/s.

A secondary issue is the reluctance of Jabiru based team members to execute by-laws with consideration to cultural, family and community ties.

COMMENT

The by-laws clearly state under Part 5, Animal Management, the obligations of dog ownership and responsibilities of the Council to respond when these by-laws are not followed.

From January 2025, several animal management complaints were submitted in writing and managed by administration in an ad-hoc manner as the preparation of standard operating procedures and formal legal framework were being developed. In August 2025, prior to completion of these documents, two particular incidences escalated in severity and administration is currently responding to these matters with the assistance of legal counsel to coordinate appropriate reply and actions.

Further to September advice, administration appointed a contractor to develop the framework, including standard operating procedures. The contractor will have the suite of documentation and processes completed for evaluation end of November. Title: Lurra Festival 2025

SUMMARY

This report is presented to Council to provide an overview of the Lurra Festival 2025 and the West Arnhem Regional Council (WARC) contribution to the event. The Lurra Festival 2025 was coordinated by Nja-Marleya Cultural Leaders and Justice Group and held in Maningrida from 15–21 September 2025.

RECOMMENDATION

THAT COUNCIL receives and notes the report titled Lurra Festival 2025.

BACKGROUND

The Lurra Festival 2025 was held in Maningrida from 15–21 September 2025. The event is a major celebration of sport, culture, fashion, music and community enterprise, designed and delivered in collaboration with local residents, outstations and youth leaders. This event exemplifies a shared vision of a vibrant, inclusive and resilient West Arnhem Region.

COMMENT

This festival was coordinated and led by Nja-Marleya Cultural Leaders and Justice Group. WARC provided on-ground support via provision of staff, supply of BBQ food, road closure management, additional amenity cleaning and access to essential equipment including scoreboards, sporting bibs, water stations, and use of basketball courts and the AFL oval and lighting. This support was provided through a combination of in-kind contributions and fee-for-service arrangements.

Council's active involvement strengthened relationships with local stakeholders, demonstrated leadership in sport and recreation, and reinforced the importance of cultural celebration as a driver of youth engagement and community wellbeing.

The Council Service Manager, Wellbeing Services Coordinator, works team and the sport and recreation team focused on the delivery of organised sport and cultural activities, as well as logistical support for major competitions. Council representatives attended pre-festival meetings, liaised directly with the Festival Coordinator, and ensured operational readiness for both basketball and AFL events.

WARC's role was highly visible across the entire week of The Lurra Festival 2025, with council contributing to ensure competitions and cultural activities were delivered safely and effectively. From pre-event preparation through to grand final night, WARC supported the community with equipment, logistics, on-ground leadership, risk management, and problem-solving. A summary of WARC's sport and recreation activities, including dates, attendance, and key operational notes, is provided in Attachment A.

This consistent WARC presence delivered well-run, culturally appropriate sporting events that attracted significant community participation and engagement and ensured that basketball and AFL competitions were properly resourced, crowd safety was maintained, and key festival infrastructure such as lighting and scoreboards operated reliably. By actively assisting with cultural highlights such as the bush oven feast, WARC also demonstrated its commitment to supporting traditional practices alongside sport and recreation.

Beyond delivery, these efforts reinforced WARC's reputation as a trusted and capable partner in Maningrida. Staff worked directly with Nja-Marleya, festival organisers, and local stakeholders to resolve challenges, build connections, and ensure the festival met community expectations.
